Families are provided with comfortable bedrooms, private bathrooms, warm meals, and all the amenities of home. We provide our services to families with a hospitalized child at Nationwide Children's Hospital, OhioHealth Systems, Mount Carmel Health Systems, and The Ohio State University Wexner Medical Center. In late 2023, the Ronald McDonald House expanded to meet the growing need of our community. Complete with 206 guest rooms, we are the world's largest Ronald McDonald House and can serve nearly 6,500 families each year.

The Ronald McDonald Care Mobile is a state-of-the-art mobile medical unit designed to meet the needs of underserved pediatric patients in central and southeastern Ohio. The mobile care unit provides wellness screenings, immunizations, hearing, vision, and development screenings and more. Additionally, consultation services are offered to local health care providers as requested.
